JUNIOR SPORTING MEMBERSHIP SCHEME

TERMS AND CONDITIONS

1. A Candidate should be referred by National Sporting Bodies or District Sports Associations; he/she may also be referred by the respective Sporting Section Conveners/Sub-committees.
2. A Candidate must be interviewed and accepted by the respective Sporting Conveners/Sub-committees. It will be up to the General Committee of the Club to approve an application.
3. A Candidate must agree to be available, when required, to represent the Club in league games for the designated sport in which he/she applies to join the Club for.
4. A Candidate must agree to attend, if available, all scheduled training sessions and participate in activities organized for the designated sport in which he/she applies to join the Club for.
5. A Candidate is to be made aware that his/her ability, progress and behavior will be monitored by the respective Section Conveners/Sub-committees, who determine his/her right to continue in the Junior Sporting Membership Scheme.
6. A Candidate will pay initial entrance fees and monthly subscriptions as follows:

Age	Entrance Fees	Monthly Subscriptions
Up to 18 years	\$1,000	\$110
From 19 to 23 years	\$3,000	\$110
From 24 to 28 years	\$5,000	\$330

7. A Candidate in the scheme may advance to a higher age-group by payment of the balance of entrance fees from one age group to the next.
8. A Candidate, on completing the Junior Sporting Membership Scheme after reaching the age of 28 years may apply as either an Associate Member or a Lady Subscriber of the Club. The entrance fees payable will be 20% of the fees payable as an Associate Member or Lady Subscriber at the time he/she joined as a Junior Sporting Member of the Club. All entrance fees paid previously under the Junior Sporting Membership Scheme will be deducted from this amount.
9. After a Candidate is accepted as an Associate Member/Lady Subscriber of the Club, he/she must agree to continue to represent the Club in the designated sport for a period of no less than three years.
10. If a Candidate, for any reason, opts out of the Scheme or has his/her membership terminated by the Section Convener, he/she forfeits all past payments made and has no claim to any refund from the Club.
11. A Candidate must also observe the rules and policies set by the respective sporting sections after he/she has been admitted as a Junior Sporting Member of the Club.
