- 2. PERSONS AGED UNDER 16 WITHOUT THE COMPANY OF AN ADULT AND PERSONS AGED 65 OR ABOVE MAY OPT TO COMPLETE THE SPECIFIED RECORD FORM.
- 3. AT LEAST TWO-THIRDS OF THE PERSONS AT THE SAME TABLE **MUST** HAVE RECEIVED THE FIRST DOSE OF A COVID 19 VACCINE.
- 4. ALL PERSONS <u>MUST SHOW</u> PROOF OF VACCINATION WHEN REQUESTED BY A MEMBER OF STAFF WHO WILL SCAN THE VACCINATION RECORD OFF THE PERSON'S MOBILE PHONE. FAILURE TO DO SO RENDERS THE PERSON LIABLE FOR REFUSAL TO BE SEATED IN ZONE "D".

PATRONS ARE REMINDED THAT FAILURE TO FOLLOW THE ABOVE GOVERNMENT DIRECTIONS WILL RENDER THEMSELVES PERSONALLY LIABLE TO A HK\$5,000.00 PENALTY IMPOSED ACCORDING TO CAP. 599F PREVENTION AND CONTROL OF DISEASE (REQUIREMENTS AND DIRECTIONS) (BUSINESS AND PREMISES REGULATION.
